We replace spring shipped daylily purchases lost within their first year in your garden.

EARLY SHIPPING:

*Fall shipping only by special arrangement. No fall shipping of new 2019 introductions.

*Pots may be picked up in the fall once we feel plants are established enough to go out.

*We give no replacement guarantee on shipments sent earlier than March.

*We will ship earlier than March only if we feel the plants have their root system established enough to be mailed.

U.S. SHIPPING BY:

U.S. POST OFFICE PRIORITY MAIL: \$15 base plus \$1 per plant.

U.S. POST OFFICE EXPRESS MAIL: Full cost paid by customer.

PLEASE INCLUDE \$20. BASE SHIPPING WITH U.S. EXPRESS ORDERS. Any remaining shipping balance due will be charged to your credit card after mailing.

FLORIDA RESIDENTS: Please add 6.5% sales tax or send us your Florida resale number.
